2023-24 School Safety Plan

Santa Clarita Elementary School provides a safe, clean environment for learning through proper facilities maintenance and campus supervision. Our Comprehensive School Safety Plan is updated annually. The plan includes sections on child abuse reporting, disaster preparedness, suspension and expulsion, dangerous student notification, sexual harassment, dress codes, and hate crime reporting. Fire drills are conducted monthly and earthquake and lockdown drills are held four times each year. The plan was discussed at our school site council and staff meetings in December/January and submitted to the Board of Trustees for approval in March.

Santa Clarita Elementary School is a closed campus. During school hours, the entrance is secured to ensure visitors check in with the front office. All visitors are required to sign in to our volunteer management system, wear a visitor's badge during their stay, and check out at the front office upon departure.

Professional Development

Our professional development focuses on providing support for our new and returning teachers. The Teacher Induction program provides support through mentor teachers to our first and second year teachers. All teachers continue to receive training in Professional Learning Communities (PLC), Technology, Curriculum, Next Gen Math, Illuminate, Constructing Meaning (CM) and Systematic ELD instructions. All through the year teachers attended workshops that focused on the use of Chromebooks and Interactive Flat Panels (IFP) in classroom instruction. Our teachers on special assignment (TOSAs) continue to provide support to our teachers, students, and administrators. Our staff continue to work in professional learning teams to analyze data which in turn drives best instruction. Our teaching staff work as professional learning communities in professional learning teams and take collective responsibilities to ensure that all students learn at high levels. Our teachers monitor student learning through ongoing common formative assessments and continue to answer the four essential questions: What do we want our students to learn? How will we know if our students learned it? What will we do if our students don't learn it? What will we do if they already know it?
